



## Summary

- Indian equities dropped for the third month in a row in February with the blue-chip S&P BSE SENSEX shedding 0.9%. The S&P BSE SmallCap underperformed its large and mid cap peers, giving up
- The performance of S&P BSE Sectors showed significant divergence, with 18% separating best-performing S&P BSE FMCG, up 0.9% from laggard S&P BSE Utilities, which plunged 17.2%.
- All S&P BSE Industries ended February in the red, with Consumer Durables holding up best, down 0.7%, while S&P BSE Power pulled at the rear, plummeting 14.6%.
- SENSEX Futures was the best performing equity strategy, slipping 1.0%, while Momentum fared worst for the second month in a row, giving up 14.6%.
- Our reported Indian fixed income indices defied the global trend of rising yields and gained across the board in February, with the U.S. dollar denominated iBoxx ADBI India being the sole exception, partially due to the Indian rupee's 1% weakening against the U.S dollar during the month.
